- Provided service in a management capacity for a school bus operator, school board/consortia or supplier company.
- In good standing with the Ontario School Bus Association for at least five (5) consecutive years and must have these requirements at the time of leaving the student transportation industry.

Notes:

No more than three (3) awarded in any given year. When more than three (3) nominations are received in any year, the unsuccessful applications will be held and considered for the succeeding year, unless otherwise determined by the current OSBA Board of Directors. Any individual, company or organization (e.g. operator, transportation manager, principal, supplier, etc.) associated with the student transportation industry may submit a nomination.
