DRIVERS DAILY INSPECTION LOG BOOK

Section 107 of the HTA and Ontario Regulation 199 / 07 requires a school purposes bus and a school purposes vehicle to be inspected on a daily basis. OSBA's log book meets the new requirement of the Regulations and is accepted by the Ministry of Transportation of Ontario. The log book lasts a full school year and one is required for each vehicle.

RECORD OF DUTY STATUS HOS (Hours of Service)

The OSBA publishes the Record of Duty Status for local drivers who drive within a 160 km of home terminal. The Record is in a 2-part form, and covers a 26 week period. The 2-part form design (using carbonless NCR paper) will allow the driver to keep a carbon copy.

OSBA Guide to new HOS (Hours of Service)

Published in April 2006, this booklet is intended to assist the school bus operators understand the major changes to the hours of services regulations implemented in Ontario in 2007.. This booklet focuses on typical short home to school and school bus day charter operations. It does not address the more complex requirements that affect longer day bus operations. (OMCA has a product available to OSBA members).
