Applies for an amendment of public vehicle operating licence PV-4150 operating licence as follows:

DELETE:

(a) there be no pick-up or discharge of passengers and express freight by the licensee between Thunder Bay and Dinorwick or any point between, for destination on Kings highway 17, 11;

SO THAT THE PUBLIC OPERATING LICENCE WILL READ AS FOLLOWS:

For the transportation of passengers (or passengers and express freight) between the City of Thunder Bay and the Town of Sioux via Kings Highway 11, 17, and its intersection with Kings Highway 72 at Dinorwick and return via Kings Highway 72 to its intersection with Kings Highway 17 and then via Kings highway 17, 11 to Thunder Bay.

PROVIDED that:

(a) chartered trips be prohibited;

(b) the licence be restricted to the use of Class "D" public vehicles as defined in paragraph (a)(iv) of subsection 1 and Section 7 of Regulation 982 under the Public Vehicles Act, R.S.O. 1990, Chapter P. 54, each having a maximum seating capacity of 15 passengers exclusive of the driver.

PROVIDED FURTHER THAT:

- 1) this authority be not construed not interpreted in favour of or against the aforesaid application in whole or in part, and any investment, arrangement or expenditure by the applicant as a result of this temporary authority be entirely at the risk of the applicant;
- 2) this be a temporary authority that shall terminate on the date of the Board's decision on the application number 47655-A
