All information pertaining to the applicant i.e. business plan, supporting evidence, etc. is on file at the Board and is available upon request.
Any interested person who has an economic interest in the outcome of these applications may serve and file an objection within 29 days of this publication. The objector shall:
1. complete a Notice of Objection Form,
2. serve the applicant with the objection,
3. file a copy of the objection and provide proof of service of the objection on the applicant with the Board,
4. pay the appropriate fee.

Serving and filing an objection may be affected by hand delivery, mail, courier or facsimile. Serving

means the date received by a party and filing means the date received by the Board.
